

Ordinance 10-2019

AN ORDINANCE PROHIBITING THE PARKING OF ANY MOTOR VEHICLE ON OR WITHIN FIVE FEET OF THE EDGE OF THE PAVEMENT ON ANY PAVED STREET, ROAD, OR HIGHWAY WITH THE CITY LIMITS OF HASKELL, ARKANSAS, ESTABLISHING A PENALTY FOR PARKING IN PROHIBITED AREAS AND OTHER RELATED MATTERS.

WHEREAS, it is found by the City Council of the City of Haskell, Arkansas, that parking any motor vehicle close to the pavement and/or on the pavement, on the streets, roads, and highways within the city limits of the City of Haskell, Arkansas, is hazardous and is a detriment to the health, welfare, and well-being of the citizens of the City and that parking adjacent to the pavement and/or on the pavement on city streets, roads, and highways, within the city limits should be regulated, and;

WHEREAS, the City Council of the City of Haskell, Arkansas, is desirous to establish penalties for parking a motor vehicle in areas in which parking any motor vehicle has been prohibited by this Ordinance:

BE IT ORDAINED by the City Council of the City of Haskell, Arkansas;

SECTION 1: It shall be unlawful to park any motor vehicle within five feet of the edge of the pavement and/or on the pavement on any city street, road, or highway within the city limits of the City of Haskell, Arkansas, unless the vehicle shall be parked in a clearly marked parking space approved by the City Council, provided for the purpose of parking motor vehicles. This Ordinance shall not apply to church or school events, organized sporting events, or other activities of non-profit organizations and/or the temporary unloading or offloading of equipment/materials.

SECTION 2: Any person found guilty of violating this Ordinance shall be fined the sum of not less than Fifty Dollars (\$50.00) nor more than One Hundred Dollars (\$100.00) for each violation. Each day the violation continues shall constitute a separate offense.

SECTION 3: The use in this Ordinance of the term "Motor Vehicle" shall include, but not be limited to, automobiles, pick-up trucks, trucks, tractors, trailers, any other vehicular conveyance intended for the purpose of carrying persons and/or goods across and/or upon streets, roads, and highways, or anything which may be pulled behind any motor vehicle.

WHEREAS, It is determined that this Ordinance is necessary and is vital to the health, welfare, and safety of the public, therefore, an emergency is hereby declared to exist and this Ordinance shall be in full force from the effect from and after its passage and approval.
