## **ORDINANCE 14-2024**

AN ORDINANCE AMENDING THE ZONING OF THE PROPERTY LOCATED AT VULCAN ROAD AND HIGHWAY 229 FROM RESIDENTIAL (R2) TO TOWN CENTER MIX (TC-MX) AND FOR ALL OTHER PURPOSES
